Terms of use for software ZAmon and ZAlift

1. USAGE PERMISSION

The information, software and documentation provided by ZIEHL-ABEGG can be - with no extra charge - exclusively used for commercial purposes by entrepreneurs (B2B). ZIEHL-ABEGG grants Users a non-exclusive and non-transferable right to use the information, software and documentation free of charge without time restriction, limited to the extent of the purpose intended by ZIEHL-ABEGG in making same available.

2. DESCRIPTION OF ADDITIONAL RIGHTS AND LIMITATIONS

Information, software and documentation may not be distributed by the User to any third party at any time nor may it be rented or in any other way made available. Unless such is allowed by mandatory law, the User shall not modify the software or documentation nor shall they disassemble, reverse engineer or decompile the software or separate any part thereof. The commercial utilization or propagation of information, software and documentation - in any form whatsoever - requires a written consent by ZIEHL-ABEGG. The User may make one backup copy of the software where necessary to secure further use in accordance with these Terms of Use.

3. COPYRIGHT

6. LIABILITY FOR DEFECTS OF TITLE OR QUALITY / OTHER LIABILITY

Any liability for defects as to the quality or title of the information, software and documentation especially in relation to the correctness or absence of defects or the absence of claims or third party rights or in relation to completeness and/or fitness for purpose are excluded except for cases involving willful misconduct or fraud.

Any further liability of ZIEHL-ABEGG is excluded unless required by law, e.g. under the Act on Product Liability or in cases of willful misconduct, gross negligence, personal injury or death, failure to meet guaranteed characteristics, fraudulent concealment of a defect or in case of breach of fundamental contractual obligations. Damages in the case of breach of fundamental contractual obligations are limited to the contract-typical, foreseeable damage if there is no willful misconduct or gross negligence.

7. DATA PROTECTION

a) Person responsible

The protection of your privacy when collecting, processing and using your personal data is of central importance to us and is something we pay great attention to in our business processes - naturally in compliance with legal requirements.

b) Contact data of the data protection officer

c) Data categories, processing purposes and legal bases

We collect, process and use your personal data, especially last name, first name and e-mail address for the purposes of

- Identification of users of ZAlift and ZAmon
- Information about new versions, bug fixes and further developments as well as if necessary new products
- Information about events, including direct advertising

The legal basis for the processing of your personal data is your consent according to Art. 6 paragraph 1 a) of the General Data Protection Regulation (GDPR).

d) Recipients or categories of recipients of personal data

If it is necessary for the improvement and further development of our products and services, your personal data may be transferred within the ZIEHL-ABEGG Group if need be. Within the ZIEHL-ABEGG Group, legally binding agreements ensure that your rights are protected. There will not be a transfer to recipient(s) outside the ZIEHL-ABEGG Group.

e) Duration of storage

We will store your personal data as long as you use our products and services. A user who is no longer active will be blocked after a year and erased after another year.

f) Your other rights

In addition, provided that the respective legal requirements are met, you are entitled to the right to information (Art. 15 GDPR), rectification (Art. 16 GDPR), erasure (Art. 17 GDPR), restriction of processing (Art. 18 GDPR) and data portability (Art. 20 GDPR). Furthermore, you are entitled to the right to object to processing according to Art. 21 paragraph 1 GDPR.

g) Consent and withdrawal

Further processing and use of your personal data beyond this shall only take place with your subsequent consent. Your

consent is voluntary and you have the right to withdraw your consent at any time wholly or partially. You can contact us to do so. The legality of processing carried out on the basis of the consent up to the withdrawal is not affected by the withdrawal of the consent.

h) Right of complaint

According to Art. 77 GDPR, you also have the right to lodge a complaint with the responsible supervisory authority if you believe that the processing of your personal data was not done lawfully.
